Clinical research and publication

I take this opportunity to invite more robust research to be planned and carried out in Asia. We need to define the research question well. A model that can help with this is the PICO(S) Framework which was originally published by Richardson et al (1995). PICO(S) is used to design a focused evidence-based medicine (EBM) clinical question. It stands for patient/ population/problem, intervention, comparison, outcome and study design/type. It is crucial that we design a specific question that we want to answer when doing research. EBM and now evidence-based practice is becoming important in wound management across the world.

I would also like to invite authors to submit their work to the journal for publication. We are a free access, Scopus indexed journal and are happy to receive all types of publications highlighting your passionate work and accomplishments in managing chronic complex or acute wounds.

WUWHS 2026 bid

I would like to inform our readers that the Malaysian Society of Wound Care Professionals (MSWCP) with the endorsement of the Asian Wound Care Association and the ASEAN Wound Council is bidding for the World Union of Wound Healing Societies (WUWHS) conference in 2026.
